

COVID19 WAIVER

Phoenix Warriors Organization, Coaches and approved representatives will endeavor to comply with all COVID-19 Return to Play policies required to participate in organized sporting events.

In consideration of being allowed to resume participation in any way within the Phoenix Warriors athletics/sports program, related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. All activities including but not limited to: practices, games, tournaments, etc. are OPTIONAL until otherwise voted on by the Phoenix Warriors board.
2. Each team within the Phoenix Warriors organization is free to decide on where they travel per coaches and parents decision.
3. The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or become infected through contact with or close proximity with an individual with a communicable disease.
4. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees or others, and assume all full responsibility for my participation.
5. It is incumbent parents or guardians enforce COVID-19 Return to Play policies including social distancing immediately before/during/after an organized event. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately. Players or parents observed violating or disregarding policy may be removed from participation in the event to prevent risk to other participants:and

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE PHOENIX WARRIORS ORGANIZATION, their officers and coaches, WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, BEFORE SIGNING BELOW, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT ON MY OWN BEHALF OR ON BEHALF OF THE YOUTH PARTICIPANT ASSOCIATED WITH THIS GUARDIAN ACCOUNT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
